Candidates who fail to reach the minimum standard for G receive no grade and a subject receiving no grade is not recorded on the certificate.

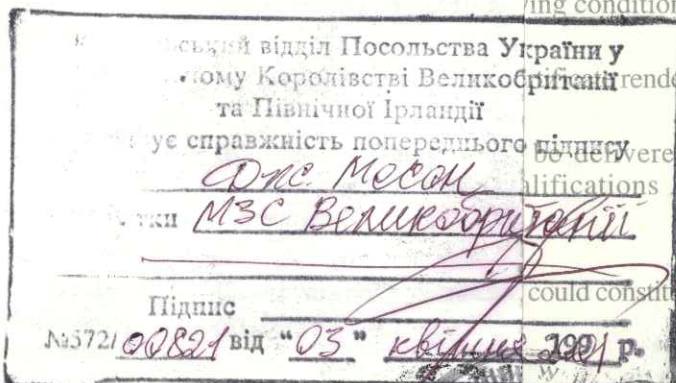
